**Assunto: Responde requerimento do Ilustre vereador Marco Antônio da Fonseca sobre as ações trabalhistas dos abonos.**


Ilustríssimo Presidente,

Esclarece que há em andamento perante a Vara do Trabalho de Itápolis, aproximadamente 470 (quatrocentas e setenta) ações relativas ao assunto abono (Leis 2.554/2002, 2.625/2003, 2.803/2005 e 2.855/2006).


Necessário, ainda esclarecer que do total acima mencionado, cerca de 400 (quatrocentos) processos são referentes a procedimento de cumprimento de sentença individual, decorrentes da Reclamação Trabalhista Coletiva movida pelo Sindicato dos Servidores Públicos Municipais da Estância Turística de Ibitinga, através do Processo nº 0099000-37.2007.5.15.0049, nos quais ainda não houve o recebimento de citação pela municipalidade.

Referida Reclamação Trabalhista Coletiva encontra-se em fase de execução de sentença, haja vista que o trânsito em julgado ocorreu em data de 05/05/2012, sendo que até o presente momento não há cálculo homologado nos autos, razão pela qual, grande parte dos servidores municipais optou por executar individualmente a sentença proferida na ação coletiva.

Assim, face à demasiada quantia de ações em andamento, não há como dimensionar eventuais valores a serem pagos ou o impacto financeiro decorrente de eventuais incorporações.

Feitos os esclarecimentos acima, coloca-se à disposição para outros que se façam necessários.

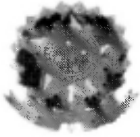

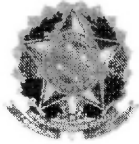
